ANNEXURE - I  
GENERAL CONDITIONS

1. The College should strictly adhere to the eligibility Conditions prescribed by the University/Government in admitting candidates for the courses offered and also to the said course.
2. The College should not admit students over and above the strength sanctioned by the University.
3. No amount should be collected from the students in excess of the fees prescribed by the University/Government or donations for appointment of persons for both teaching and non-teaching positions.
4. The college should adhere to the Tamil Nadu Government reservation Policy in admitting candidates and appointment of staff.
5. There shall be no financial commitment on the part of the State Government or University on account of the course being started by the college.
6. The College should pay salary to the teachers as prescribed by the Government/UGC/AICTE.
7. The college should provide space and facilities to the University to conduct examinations and for other academic purposes as and when required.
8. The Course noted above has only be granted as an unaided course.
9. The students shall be permitted to appear for the First year/First Semester examination only after 180/90 working days or 720/450 hours from the date of receipt of this affiliation order.
10. The Management should get the Continuance of Affiliation for the above course every year.
11. The approved syllabus for the above course can be had from the Board of Studies section of this University.

ANNEXURE - II  
SPECIFIC CONDITION

1. To produce the original sale deed for having purchased 16.56 acres of land in survey numbers 1211, 1224, 1225, 1226, 1227, 1228 part and 1229 part of Thimmarasanaikanur village, Aundipatty, Theni District within a period of sixty days from the date of grant of temporary affiliation.
2. To produce evidence of having obtained the permission from the railway authorities to cross the railway line.
3. If the conditions 1 and 2 are not complied with in time temporary affiliation will be withdrawn and the college should not entertain fresh admissions.
4. All the conditions stipulated in the reports of the Inspection Commission shall be fulfilled on or before 1.3.1999.
