The Management should submit a duly signed undertaking on a Rs. 20/- non-judicial stamp paper to the Registrar, Anna University of Technology Madurai, Madurai - 625 002, within 15 days from the date of receipt of this letter to the effect that the conditions specified above will be fulfilled.

If at any point of time during an inspection or surprise inspection it is found that the norms standards and prescribed are not maintained by the college provisional affiliation granted above will be withdrawn without notice.
