In the letters first read above, the Principal, Bharat Nicketan Engineering College, Theni has requested the Government to approve the M.E. (Industrial Safety Engineering) Course, a qualification necessary for the appointment as Safety Officer under Rule 3 (1) (b) of the Tamil Nadu Safety Officers (Duties, Qualifications & Conditions of Service) Rules, 2005. He has stated that the college has obtained provisional affiliation from Anna University of Technology, Madurai, for the intake of 18 students for the academic year 2011-2012 for the course M.E (Industrial Safety Engineering) and also obtained similar approval from All India Council for Technical Education for the academic year 2011-2012. Details regarding Syllabus and all the infrastructure information as well as faculty are as per rules in force.

2. The Chief Inspector of Factories has recommended for granting recognition for the above said course proposed to offered by Bharat Nicketan Engineering College, Theni.
